In honor of Julio Castelo Matrán, who was the president of MAPFRE and a major driver of its development, Fundación MAPFRE decided to create the Julio Castelo Matrán International Insurance Award, designed to recognize scientific works or innovative projects regarding topics related to Insurance and Social Protection. Julio Castelo is currently Honorary President of Fundación MAPFRE.

# 10TH INTERNATIONAL INSURANCE AWARD JULIO CASTELO MATRÁN

## CALL RE-OPENING 2019/2020 TO RUN THROUGH 2021

### COMPETITION RULES

Fundación MAPFRE reopens the call for the **10th edition of the Julio Castelo Matrán International Insurance Award 2019/2020** which, due to force majeure derived from the global pandemic generated by COVID-19, was forced to be suspended on 30th March 2020. This award is intended to support scientific work related to Insurance and Social Protection.

It will be awarded on the basis of the following rules:

#### FIRST

The Julio Castelo Matrán International Insurance Award takes place every two years and its call for applications has a worldwide scope. As mentioned above, its tenth edition was suspended on 30th March 2020 due to the COVID-19 pandemic. This edition has been re-opened in the current extraordinary circumstances, and will take place during 2021, resuming its biennial character once this call is over.

Individuals or institutions who have developed significant scientific work whose findings contribute to expanding the insurance business in society and bringing about economic stability and solidarity through Insurance and/or Social Protection are eligible to apply for this award. To be eligible for this award, the candidate (an individual or an institution) must comply with the requirements of the section entitled "Documents to be attached" of these rules.

The following works will be considered:

- Unpublished scientific works or those that have been published in the last four years (taking as a reference point the date of closure of this call, indicated in rule 6) which contribute to a greater knowledge of Insurance and Social Protection.
- The transferability of the activity to other countries or regions shall be taken into consideration in both cases.

## **SECOND**

The assessment of the entries and the decision on the finalists and their order shall be carried out by a judging panel appointed by Fundación MAPFRE with the capacity to:

- Adopt whatsoever initiatives they deem necessary in order to compare information on the entries submitted.
- To cancel the granting of the award if the entries submitted fail to meet the minimum requirements established in the call.
- Remove the title of winner and appoint other alternatives in the event that said winner fails to attend the award ceremony.

## **THIRD**

The judging panel's decisions shall not be subject to appeal and, at their suggestion, Fundación MAPFRE shall not grant the Award if the applicants do not meet the required level expected. The Fundación MAPFRE Board of Trustees is authorized to adopt the appropriate resolutions in order to interpret these rules, which shall be deemed accepted by the candidates by the very fact that they have taken part in this award's call for applications.

## **FOURTH**

The award shall be decided on July 2021. It shall be notified to all the applicants or, in the case of co-authored works, to the entry's representative, and shall be published on Fundación MAPFRE's website and disseminated in any media outlets the latter deems appropriate.

The Award shall be presented in 2021 in a public ceremony which shall be announced in due course.

The person or entity who is judged the winner and/or, in the case of co-authored works, the entry's representative, if applicable, undertakes to attend the Award ceremony in person, as well as to:

- Provide graphic materials (with copyright) for the communication of the jury's decision and the design of the ceremony.
- Take part in any interviews scheduled for the day of the award ceremony.

Failure to comply with these requirements could lead to the removal of their status as winner, at Fundación MAPFRE's discretion. The award will then go to the following finalist selected.

## **FIFTH**

Neither the judging panel nor Fundación MAPFRE are required to hold correspondence with any of the award applicants, nor to return the originals of the works nor any reports that may have been submitted which, in the event of not being chosen as the winners, shall be destroyed under the terms stipulated in rule 12.

## **SIXTH**

All those who had applied before the suspension of the initial call, launched on 21 October 2019, will not have to reapply as their application is registered and will be taken into account in the final list.

Co-authored scientific works may be submitted for this award. In such cases, only one entry needs to be submitted which must identify the entry's representative, who will act on its behalf and as the contact person for the organization of the Award. All references contained in these rules to the applicant or winner (an individual) shall be understood to be made to each one of the co-authors, unless indicated otherwise.

The applications and documentation should be submitted in English, Spanish or Portuguese by the applicants themselves by means of the following procedure:

- Applicants have until 23:59 (UTC/GMT+1) on 31 May 2021 to send us their contact details by way of application through the form provided at [www.fundacionmapfre.org](http://www.fundacionmapfre.org).
- Subsequently, the applicants or in the case of co-authored works, the entries' representatives, will receive an email requesting certain documentation from them which they should provide us with by email.
- The deadline for sending the documentation is 7 June 2021, inclusive (until 23:59, UTC/GMT+1).
- The same person may submit or take part as the co-author of various works. A separate entry will be required for each one of them.

## SEVENTH

Scientific works submitted to this tenth call for applications must have been carried out by the applicant after June 2017.

## EIGHTH

No employees of any of MAPFRE's entities nor their direct family, up to the second degree of kinship may take part in this call.

## NINTH

The applicant shall be liable for the truthfulness of the documentation submitted. The scientific works shall be original works. Submitting these works shall amount to the broadest declaration of its authenticity.

The works may have been published in the last four years, taking the closing date of this call as a reference point, as indicated in rule 6.

If Fundación MAPFRE were to request it, all applicants undertake to produce the originals of any of the documents provided in their application, or a certified copy of them.

## TENTH

The gross amount of the prize is **30,000 euros**, subject to tax and anti-money laundering regulation in force in Spain. In order to comply with the requirements established by the Spanish Law for the Prevention of Money Laundering and the Financing of Terrorism (Art. 2 of Law 10/2010 of 18 April) and its Regulations (RD 304/2014), the prizewinner must submit to Fundación MAPFRE any documents required by the latter in compliance with said legislation, as a prerequisite for receiving the award. See document **attached**.

If the winning work is a co-authored work, all the authors will be awarded ex aequo.

## ELEVENTH

Fundación MAPFRE is hereby authorized for an indefinite period of time to publish worldwide and in any language, through the means of dissemination it considers most appropriate, the summary of the award-winning scientific work, which must be a maximum of 2000 words in length and should highlight the contributions made.

In the case of unpublished works, Fundación MAPFRE is hereby authorized to publish their full content, reserving the rights to public communication, editing, transformation, publication and dissemination worldwide, for an indefinite period of time and in any language and in any format, whether analog or digital, and particularly in order to make public communication of it on the internet.

## TWELFTH. PRIVACY AND DATA PROTECTION

The candidate is informed and gives his express consent, when registering in this call, the processing of personal data for the management of his registration and participation in this tenth edition of **Julio Castelo Matrán International Insurance Award**, being Fundación MAPFRE the entity responsible for the treatment.

In the event that the data provided refers to third parties other than the candidate, the candidate guarantees to have obtained and have their prior consent for the communication of their data and to have informed them, in advance, of the purposes of the treatment, communications and other terms provided in this document and in the Additional Data Protection Information.

- A photocopy of the national identity card, passport or personal identity card of the individual applicant or the Corporate Tax ID number (CIF) of the company submitting an entry. According to rule Sixth, in the case of co-authorship, all references to the candidate (an individual) must be understood to refer to each of the co-authors, unless otherwise indicated, and therefore the identity document, passport or identity card of all of them must be submitted.
